Rolled Maps & Plans were either too large to be stored in flat files or they could not be folded without damaging the document,. Rolls may contain more than one document. The term "Set" indicates that the items have a direct association with each other, generally as part of the same project. "Group" indicates that items may be generally related by type, subject, or location as indicated on the label. Caution is advised in handling and unrolling items as they may be in fragile condition. The medium on which older documents were printed was often cut unevenly so the edge of the document is also uneven. Rolls should be lifted from the bottom or tube end. Items are labeled on the wrapper, center and ends, and on the attached paper tag. All items are stored on shelves or in the metal cabinet in the locked collections storage area
